- Discrepancy between amounts on tiers and the exposure they'd get but incentive to go to higher tier?
- On platinum level it says limited availability why?
 - Scarcity so sponsors have a sense of exclusivity
 - Logistics can't fit many sponsors on each sign

- Potential for \$10,000 platinum tier?
 - o 16 tees advertising, social media, website, etc.
 - Platinum (\$10000), gold (\$5000), silver (\$1000), bronze

- Enough room for two large logos on the signs? Maybe not maybe just have one large logo
 - \$5000 tier smaller logo, but still on all the signs
 - Silver same place but not on all the signs
- No course naming rights
- Get a quote for course signage
