#### 4. Old Business

- 4.1 Sponsorship progress
  - 4.1.1 Letter distribution

      - Make sure the letters have been properly received

    - We can send Justine a generic letter, if she encounters someone she thinks would be interested she could give it to them Sharon will send this to her and also a list of businesses we have already delivered letters to
  - 4.1.3 Contributions
    - Three businesses have sponsored so far
- 4.2 Financial overview

- 4.3 Bag Tag League
  - Limited new challenges occurring
  - Should there be a stipulation that all league players must challenge at least once?
    - Implement this rule the next time we do a league like this

    - Jaxson will draft up a message and send to Sharon
- Make the challenging rules less stringent, so players can challenge in a larger radius
  - Remove back-to-back challenge stipulation
  - o Include this in the memo too say we are opening up the rules a bit
- Get this message out before next Wednesday

#### 5. New Business

- 5.1 AGM
  - Need to announce it at least 30 days beforehand
  - Have it following the September tournament?
    - Not a guarantee that this tournament is happening
  - Announce the date, then we have a full month to figure out what it will look like if the tournament doesn't happen, we can organize the AGM outside of that
    - o September 28
  - In the message to members, say what quorum is and how many need to be there
- 5.2 2025 Canadian Women's Event
  - Sponsorship for prizes would be difficult, because we are already asking businesses for sponsorship for the course
    - Not a surety that we will have the course by then
  - Would be May or June 2025
  - They want to plan ASAP, but it would be difficult for us to commit right now
  - Let them know that our priority right now is getting the course done
  - Ask how soon they need to know, and if that is too soon for us, we can let them know we aren't able to this year but maybe next year we can
    - Sharon will send this message
  - Sponsorship: reach out to manufacturers? More hesitant to ask local businesses again

#### 5.4 September Tournament

- We could offer to put the flags in for basket placements on the Friday
- Fundraiser for the course
